Town Hall: 2020 Street Paving Program Thursday, January 23rd at 7:00 pm UDT Building

A town hall meeting to discuss the 2020 road improvement program has been scheduled for Thursday, January 23rd at 7:00 pm in the Main Meeting Room at the Upper Dublin Township building. The purpose of the meeting is to provide information about the program, how roads are selected and a review of the curb, sidewalk, and driveway apron replacement requirements. Residents will have an opportunity for discussion and questions pertaining to the road program.

Air Force \$2.8 million to Stop PFAS Flow

The Air Force will spend \$2.8M to permanently stop PFAS from flowing off the Navy Base in Willow Grove and into the water supply. This is a major victory for our community and for those citizens and local officials who have fought to address PFAS contamination.

2020 Budget

The township real estate tax increase for 2020 is 2.5% (\$29), increasing from an average of \$1,181 to \$1,210 annually for a residential property assessed at \$202,000.

"Cross Traffic Does Not Stop"

The intersections of Woodland & Dundee, Arran & Aidenn Lair, and Wellsly & Glen Echo are being monitored by UD Police to see if traffic demands that the "Cross Traffic Does Not Stop" signs be put up there. Please let me know if the posted signs are working. Thanks.

UD Awarded \$520,000 in Grants for **Twining Valley Park**

UDT was awarded \$520,000 in total grants for Twining Valley Park. The Township hopes to begin work this summer.

Chlorine Taste in AQUA Water

If you have noticed a change in the taste of your water from Aqua, it could be from chlorine. Chlorine tends to be more noticeable in the winter months. While Aqua adds the same amount of chlorine year round and monitors it. chlorine doesn't dissipate as readily in colder water. It can impart a chemical or even bitter metallic taste at times.
