Good Morning Everyone,

First, we look forward to having you all in DC next week to meet with representative from the Department of Defense, EPA and CDC. I anticipate that it will be a productive meeting, and will provide a good opportunity to everyone to ask some very specific questions of those federal agencies.

We are finalizing an agenda that I hope to send around later today.

In the meantime, I wanted to be sure that everyone had the correct address for the meeting: It will be held in the Russell Senate Office Building – Room 385, Washington, D.C., 20510. Our office is Room 393, so it's just down the hall from the Senator's office so you're more than welcome to check-in there before heading to Room 385. An interesting side note, our current Senate office is the office JFK used during his time in the Senate.

The following is a link to a map of the Capitol complex: <https://www.visitthecapitol.gov/plan-visit/us-capitol-map>. The main entrance to the Russell Senate Office is located at Constitution Avenue, NW and Delaware Avenue, NE.

If you're taking the train to DC (as you can see from the map), Russell is the closest building to Union Station, so it's short 5-10 minute walk. If you're driving to DC, Union Station is also the easiest place to park, with a short walk to Russell.

If anyone has any other questions, I'm happy to try and answer them for you. We'll have name tents for everyone in the meeting. Also, if anyone would like to setup a tour of the Capitol or another building in DC, perhaps for the afternoon, our office is happy to try and help with that as well. However, the timing is a little too close for us to set up anything at the White House.

Finally, and this is not required, but in preparing the memo for this event I was going to include a few sentences for everyone. If you have a brief bio that would like me to include, please send it by COB on 9/20.
